WVPY(TV), Front Royal, VA (Facility ID 66378)

WVPY(TV), Front Royal, VA (the “Station”) is currently operating its Channel 42 analog transmitter at reduced power due to the failure of two amplifier modules. The Station’s engineers have attempted to repair the amplifier modules, but have been unable to achieve the authorized effective radiated power (“ERP”) of 141 kW, instead achieving an ERP of approximately 80% of the authorized ERP. The Station has contacted the equipment manufacturer, which has informed the Station that it would require approximately three weeks to complete the necessary repairs. Accordingly, because the repairs will not be completed prior to the February 17, 2009 digital transition, the Station respectfully requests Special Temporary Authorization (“STA”) to operate at reduced power until it permanently ceases analog operations.
